

## 12.1 Radiology

Southwest Medical Associates (SMA) provides radiology services at multiple locations. The facility located at 888 S. Rancho Drive offers extended hours for urgent situations. SMA offers select exams at additional facilities, which operate during normal business hours.

All radiology exam require a signed order from the provider. CT, Ultrasound and Fluoroscopy require appointments. X-ray (plain film) does not need an appointment. Appointments can be made by contacting the radiology scheduling department.

Physician Exam Order:

- Diagnostic Mammogram Orders are valid for six (6) months.
- Screening Mammography and DEXA orders are valid for twelve (12) months.
- All other orders, CAT scan, Ultrasound, fluoroscopy, General Radiography, etc... Are valid for six (6) months with the exception of Urology Specialists of Nevada.

#### Southwest Medical Associates Mammography Guidelines

##### Screening Mammography

Screening mammogram for female patients ages **35 or older**:

- Must have an order (patients can self-refer if they are over 40+)
  - General breast pain or tenderness
  - Fibrocystic breasts
  - Yellow, green, white or milky discharge

Screening mammogram for female patients age **34 or younger**:

- Must have an order (no self-referrals)
  - Typically done for pre-augmentation purposes
  - Genetic testing and/or a strong family history of breast cancer (first degree relative)

##### Diagnostic Mammography

Female patients ages **30 or older** must have a diagnostic mammogram **FIRST**:

- Must have a diagnostic order/referral
  - New mass or lump
  - Rule out breast implant rupture (patient can be ANY age)-NO BCP VISIT, IMAGING ONLY
  - New onset nipple retraction, skin puckering or thickening
  - Bloody, black or clear discharge
  - Focal breast pain **ONLY** (please provide location)
  - First mammogram after being diagnosed with breast cancer (if the patient had a mastectomy unaffected breast can resume screening mammogram)
  - **EXCEPTION:** if a patient had a mammogram within the last 6 months and presents with a new lump, nipple retraction, skin puckering or discharge, a breast ultrasound should be completed first

Female patients ages **29 or younger** must have a *breast ultrasound* **FIRST**:

- Must have a diagnostic order/referral
  - New mass or lump
  - New onset nipple retraction, skin puckering or thickening
  - Bloody, black or clear discharge
  - Focal breast pain ONLY (please provide location)

### Male patients:

- Must have a diagnostic order/referral
  - All males 18 and over require a diagnostic mammogram first, unless they are of pediatric age (please see pediatric patient guidelines)

### \*\*\*\*PLEASE NOTE:

- If a patient presents with an issue that has already been imaged within the last 12 months with normal results and there are no **NEW** changes, referral may be declined.
- Breast Ultrasound referrals for dense breast will be declined.

### **Pediatric Guidelines:** 17 years and under:

- Pediatric females 12 years of age through 17 years of age are to be scheduled at a breast imaging center. These patients are no breast care (NBC) but receive a BIRADS preliminary reading and get results from their ordering PCP.
- All pediatric males are ordered and scheduled as an US Miscellaneous (USMISC) and do not receive a BIRADS reading. They can schedule at any general ultrasound location. If the exam is normal there is no need to show the radiologist.
- Females under 12 years of age are ordered/scheduled as an US Miscellaneous (USMISC) and do not receive a BIRADS reading. They can schedule at any general ultrasound location. If the exam is normal there is no need to show the radiologist.

Radiology reports are available in 24-48 hours and are faxed to the requesting physician's office. Finalized reports can be mailed to a physician's office if requested by the physician or designated staff. Arrangements for fax may be made by telephoning **(702) 877-5125 (option # 5)**.

**Imaging Expectation Sheets and Member Instruction Sheets – Please see Section 24 for copies of these frequently used forms**

Timelines for diagnostic tests performed in the SMA Radiology department are as follows:

- Expedited requests – studies done within 72 hours
- Routine requests – studies done within 14 days
- STAT Referrals will be handled according to the below process.

### **Important Note:**

Because of department limitations, all requests for STAT examinations must be done between the hours of **8:00am to 4:00pm; M-F and 3pm for CT with oral contrast.**

**Providers ordering a STAT study MUST call (702-877-5002) scheduling to get a time and location for the patient to be seen.**

Providers ordering a STAT study need to furnish the scheduling department with two contact numbers an office land line and provider cell phone number for direct telephonic result notification, an ETA of the patient arrival, a referral with appropriate clinical information and all necessary lab results.

If the patient needs I.V contrast and is 61 years of age or older, diabetic, or has a history of renal disease, please provide current (within 30 days) BUN and Creatinine levels. If lab tests have not been completed, please order them stat (STAT lab results may take up to 6hrs.)

Please instruct Patients to arrive by **arrive by 4:00pm; and 3pm for CT with oral contrast.** If Imaging is unable to contact the requesting Provider with results, the patient will be directed to check in through the Urgent Care for Evaluation & Treatment.

**Ultrasound** – STAT ultrasound exams will be performed at Rancho location only.

**Ct scan** – STAT CT scan can be performed at Rancho, South Eastern or North Tenaya location

**Screening Mammography** – Mammography is not done on a STAT basis.

**General Radiology** – Services are available during the identified hours at all SMA locations.

**General Xray:**

Scoliosis xray on 1- image (SMA performs scoliosis on 2 images) can be done **at 888 S. Rancho only**

Leg length xray on 1-image (SMA performs leg length on 3 images) can be done **at 888 S. Rancho only**

**EGD + Colonoscopy** – Please refer to Gastroenterology

**Cardiology Testing** – Please refer to Cardiology.

**Modified Barium Swallows (74230)** – Please refer to Speech Therapy.
